# III. CONSIDERATION OF PROPOSED ADMINISTRATIVE DECISION (Item 3)

a. In the Matter of the Retirement Benefits of: Teresa Sordello

The committee received a presentation from Mr. Lindsay and Ms. Lopez-Trotter regarding the proposed decision by the administrative law judge in *In the Matter of Retirement Benefits of: Teresa Sordello*. The committee sought clarification about which life events would qualify a member for an option election change outside the statutory period,

as referenced on page eight of the administrative law judge's proposed decision. The committee discussed the member's retirement history which included Ms. Sordello's first retirement in 2009 where she elected a "member-only benefit." The committee also confirmed that the member delayed in inquiring about an option election change for more than two months after the statutory deadline had passed.

The committee heard from Teresa Sordello who expressed her issues with the proposed decision.

Staff recommended the committee adopt the proposed decision, with the technical or other minor changes identified in the committee materials on Item 3a, page 3.

#### IV. EDUCATION: APPEAL ISSUE SERIES - ACCOUNTING (Item 4)

The committee received a presentation from Ms. Arbuckle from the Accounting division regarding an overview of the appeal issues it has administered in the last five fiscal years. The presentation included a review of the current appeal process, as well as charts detailing the number of Decision letters and Executive Review requests the Accounting division has administered.

The committee commented that since the 2016/2017 fiscal year, all appeals administered by the Accounting division had been resolved without the need for an administrative hearing. Further information was presented to the committee which distinguished the typical appeals administered by the Accounting division versus other business areas.

The committee received a staff report from Ms. Minoya concerning upcoming scheduled administrative hearings and the scheduling needs for future committee meetings.
