<u>AB 65</u> (Aguiar-Curry) Introduced: 12/3/24	CTA, CFT, FACCC, CSEA, State Superintendent of Public Instruction, State Treasurer	Provides for up to 14 weeks of fully paid leave for California public school employees for pregnancy, miscarriage, childbirth, termination of pregnancy or recovery from those conditions. Prohibits a leave of absence for any of these reasons from being deducted from other leaves of absence available to the employee.	Support	Senate Floor (Inactive File)
<u>AB 1439</u> (Garcia) Amended: 8/13/26	State Building & Construction Trades Council of California	Requests that the UC Berkeley Labor Center study, among other topics, the extent of labor standards protections in California development projects funded through the real asset portfolios of CalPERS and CalSTRS and the impact of labor standards protections on California's economy by January 1, 2028. Also requests that CalPERS and CalSTRS provide the labor center with relevant data within 60 days after receipt of a written request.	Monitor	Governor's Desk
<u>AB 1619</u> (Valencia) Amended: 4/23/26	Orange County Employees Retirement System	Among other changes, amends Education Code section 22223 to increase per diem compensation for specific Teachers' Retirement Board members from \$100 to \$320.	Neutral	Governor's Desk
<u>AB 2417</u> (Zbur) Amended: 8/13/26	CFT	Requires temporary employees at community college districts to be provided with the option of membership in the Defined Benefit (DB) Program, the Cash Balance (CB) Benefit Program, if offered, or Social Security (SSA). Also requires, by July 1, 2027, CalSTRS, in consultation with CalPERS, to provide links to information regarding the DB Program, the CB Benefit Program and SSA on its websites and community college districts to provide this information to newly hired temporary employees. <u>AB 2519</u> (McKinnor) Amended: 4/20/26	Author	Amends the definition of “position subject to membership” as added by AB 1997 and effective July 1, 2027, to include positions at charter schools that are currently eligible for membership. Also, adds “permit” to the list of documents that may be required for a position subject to membership and codifies the effective date.	Monitor	Governor’s Desk
<u>AB 2780</u> (PE&R) Amended: 8/6/26	CalSTRS, State Association of County Retirement Systems	Makes minor, technical and conforming changes to the Teachers’ Retirement Law to facilitate efficient administration of the State Teachers’ Retirement Plan, which includes the DB Program, the Defined Benefit Supplement Program and the CB Benefit Program. Also makes various minor, technical and conforming changes in the Public Employees’ Retirement Law and County Employees Retirement Law.	Sponsor	Governor’s Desk
<u>SB 1319</u> (Durazo) Amended: 4/15/26	Unite Here Local 11, United Food and Commercial Workers Union, Western States Council	Requires public investment funds to disclose, upon request, additional information related to alternative investments by expanding the information not considered to be a trade secret exempt from disclosure under the California Public Records Act. In addition, requires the annual reporting of specified information related to alternative investments through a cross reference in another Government Code section. <u>H.R. 9732</u> (Casten-IL) Introduced: 7/16/26	Author	Directs the Securities and Exchange Commission to require issuers with two or more classes of voting securities to disclose shareholder meeting vote results disaggregated by voting class, as specified.
