III. TRIENNIAL HEALTH BENEFITS STUDY (Item 3)

The committee received a presentation from Mr. Buffalo on the results of the Triennial Health Benefits Study. The committee received detailed information about annual healthcare costs, the cost of healthcare relative to inflation, as well as the potential gap in health insurance coverage for retirees under the age of 65 who are not yet eligible for Medicare. The committee also received information concerning the issue of healthcare coverage for temporary and nontenured community college faculty, including the need for more comprehensive data on this member population.

The committee inquired about the issue of healthcare coverage for community college faculty. The committee discussed how disparities in health coverage do occur for part-time community college faculty, and that union efforts to address these disparities have not always been successful. The committee further discussed how to obtain better data for this member population so that there would be more transparency on the issue.

The committee also discussed the healthcare coverage for members between the ages of 61 and 65 years old, and commented on the importance of healthcare planning, recognizing that members cannot always anticipate when health issues arise.

IV. RETIREMENT READINESS MEMBER EDUCATION & ENGAGEMENT EFFORTS (Item 4)

The committee received a presentation from Ms. Blair regarding the efforts made to engage with members about their retirement options. The committee received detailed information on past and present member education and stakeholder engagement efforts, the improvements in benefit planning that have been made in recent years and during the pandemic, and finally, the status of member participation in the Pension2 program.

The committee discussed the value of being proactive and personalized when engaging with members about their retirement options. The committee also inquired about the role that technology plays in maintaining direct contact with members throughout their career.
